





SECURE VEHICULES OR CONTAINERS

The TIR convention stipulates that goods shall be carried in containers or road vehicles the load compartments of which are constructed in such a way that there shall be no access to the interior when secured by a customs seal and that any tampering will be clearly visible. To this end, the convention sets out standards of construction, as well as approval procedures.



INTERNATIONAL GUARANTEE

Every national association, representing the interests of the transport sector in a particular country and authorized by the government of that country, guarantees payment - within that country - of any duties and taxes which may become due in the event of any irregularity occurring in the course of a TIR operation.



TIR CARNET

The TIR carnet is an international customs document and constitutes the administrative backbone of the TIR system. It also provides proof of the existence of an international guarantee.



CONTROLLED ACCESS

Annex 9 to the convention stipulates conditions and requirements for the authorization, by national competent authorities (usually customs authorities), of national associations to issue TIR carnets and to act as guarantor.



MUTUAL RECOGNITION OF CUSTOMS CONTROLS

The customs control measures taken in the country of departure should not be repeated by the countries of transit and destination. More specifically, goods carried under the TIR procedure in sealed load compartments of road vehicles or in containers will not, as a general rule, be examined at customs offices 'enroute', and that is where the main advantages of the TIR system for the transport operator come into play.

Electronic Data Exchange



- TIR allows logistics operators to submit trade data to customs in fully electronic and safe environment via IRU's IT tool called TIREPD that is integrated to 43 countries' customs system.
- The advance submission of trade data ensures that all customs on the route able are to perform the necessary risk management, prior to the shipment's departure and in a fully digital







Difference in Border Crossing Cost

TIR & TIR-EPD prioritisation

Facilitation on the ground



In Turkmenistan, TIR-EPD Green Lanes opened at all key BCPs, allowing separation of entry traffic



In Moldova, submission of advance cargo information via TIR-EPD is mandatory from 1 August 2022. Prioritisation work for TIR continues at Costesti-Stynka BCP. TIR prioritized at Romania Albita and Siret Borders.



In Saudi Arabia, customs approved the "Express Lane" of AEO for TIR operators at AI Batha and King Fahad Causeway customs. TIR lanes allow TIR transport to cross this border 92% faster – 4h vs 48h in average
